

## **Slavery & Human Trafficking Statement**

Modern Slavery is a crime and a gross violation of fundamental human rights. It takes various forms, all of which have in common the deprivation of a person's liberty by another in order to exploit them for personal or commercial gain.

We have a zero-tolerance approach to modern slavery and are fully committed to preventing slavery and human trafficking in our corporate activities. We are also committed to ensuring there is transparency in our own business and in our approach to tackling modern slavery throughout our supply chains, consistent with our disclosure obligations under the Modern Slavery Act 2015. We all have a responsibility to be alert to the risks, however small, in our business and in the wider supply chain.

This statement sets out Coltman Precast Concrete actions to understand all potential modern slavery risks related to business and to ensure steps are maintained to prevent slavery and human trafficking.

### **Our Business**

Established in 1972, Coltman is now one of Britain's largest independent suppliers of precast concrete products to the construction industry.

Our service is complete and covers each and every aspect of precast concrete products, from design, manufacturing and testing, through to installation on site.

As an independent company we have enjoyed planned, consistent growth and have built up an enviable reputation for the quality of our products and excellent relationships with our customers.

These include the country's leading names in architecture, construction, civil engineering and property development. We've also been involved in many prestigious projects from multi-million pound city redevelopments to quality civic cultural centres to premier sports arenas and stadiums.

### **Our Supply Chains and Supplier adherence to our Values**

The relationship with all our suppliers has been established over a number of years and is built upon mutually beneficial factors, where we have close and personal links and contact with the owners or directors, typically reflecting the fact that we partner with Small and Medium sized operations in the main.

As and when we have new contractors or suppliers come on-board we pre-qualify any new firm through a series of diligence, relating to company performance, HS&E compliance and references from other customers to establish that they are suitable.

To date we haven't been made aware of any human trafficking / slavery activities within the supply chain but if any were highlighted to us then we would act immediately in accordance with our legal and moral obligations.

### **Our Policies on Slavery & Human Trafficking**

We are committed to ensuring that there is no modern slavery or human trafficking in our supply chains or in any part of our business. Our Anti-Slavery Policy reflects our commitment to acting ethically and with integrity in all our business relationships and to implementing and enforcing effective systems and controls to ensure slavery and human trafficking is not taking place anywhere in our supply chains.

### **Due Diligence Processes for Slavery & Human trafficking**

As part of our initiative to identify and mitigate risk we have in place systems to:

- Identify and assess potential risk areas when considering taking on new suppliers and regularly review our existing supply chains.
- Mitigate the risk of slavery and human trafficking occurring in our supply chains.
- Monitor potential risk areas in our supply chains.
- Protect whistle blowers.
- Training
